Sanctuary 10-0-10 can be applied throughout the growing season at a wide range of nitrogen rates. This all-season product delivers the turf nutrients essential for excellent growth, color and turf density.

Directions for Environmental Maintenance Programs: Apply 10 lbs. per 1000 sq. ft. for 10 to 12 weeks of residual color. This product is ideal for applications adjacent to lakes and waterways where phosphorus run-off is a concern.

Late Fall Application Program: Apply 10 lbs. per 1000 sq. ft. as a late fall rate for winter stress tolerance and spring color.

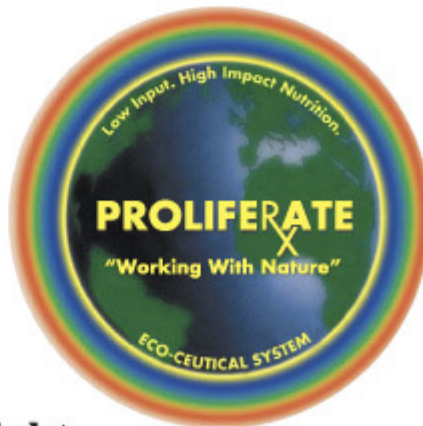
