



Soil Life 8-3-6 is a blend of protein meals inclusive of feather, fish, meat & bone and blood meals. This natural based product provides a flat linear release of nutrients that offers outstanding residual color. The high water insoluble product is ideal for slow, even growth & color, summer stress applications, for turf recovery after aeration and as a late fall feeding. This product is also an excellent pre-plant base nutrient application for flower, ground cover and ornamental beds.

Direction for Use on Turfgrass: For a general nutrient maintenance program apply 6 to 12 lbs. per 1000 sq. ft. at a 4 week interval to optimize color and growth. The higher rate is recommended for first time users as a soil priming application.

Direction for Use after Aeration: Apply 12.5 lbs per 1000 sq ft after aeration for turf recovery and root development.

Direction for Use in the Fall: Apply 12.5 lbs per 1000 sq ft as a late fall application for root development and outstanding spring color.

Direction for Use for Turf Establishment: Apply 25 lbs per 1000 sq ft as a seedbed preparation incorporated into the top 4 inches.

Direction for Use for Color Beds & Bulbs: Incorporate 25 lbs per 1000 sq ft prior to planting to enhance establishment. Apply 12 lbs per 1000 sq ft every 45 to 60 days for continued summer blooms

Watering Directions

The product can be applied to wet or dry or stressed turf without any problems. For product breakdown, the key is WET – DRY – MOW. The product is applied and lightly watered – one cycle or revolution of the irrigation head. These products have a sugar binder. It is held together by sugars under pressure from the manufacturing process. The water aids in dissolving the sugar and releasing the pressure. The granular will begin to swell as the product dries. The product is ready to mow when dry to touch. It is recommended to mow without baskets to avoid picking up the product. For shorter mowing heights, a lower application rate at more frequent intervals is recommended. A dew whip can enhance breakdown and speed mowing.
