USE SUMMARY

RATES: Maximum Individual Application Rates

Cool-season grasses	2-3 pts/Acre
Bentgrass (<i>except golf course greens and tees</i>).....	1.5-2 pts/Acre
Warm-season grasses	2-3 pts/Acre

Limited to two applications per year.

Maximum 4 pints of product per acre per application.

Maximum seasonal rate is 8 pints per acre excluding spot treatments.

For sod farms, use a minimum of 21 days between applications.

APPLICATION RESTRICTIONS

Do not use on residential turfgrass. Do not collect grass clippings for mulch or compost. Do not send clippings to a compost facility. Applicator must give notice to landowners/property managers to not use grass clippings for mulching or composting.
