### Section 4. First aid measures

#### Description of necessary first aid measures

- Spill** :

### **Precautions for safe handling**

- Protective measures** :

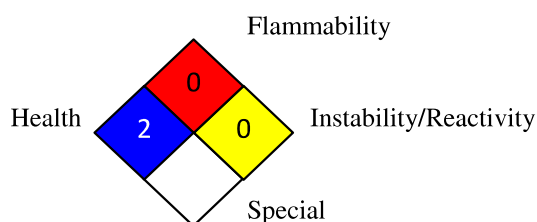
