4. First-aid measures

6. Accidental release measures

Personal precautions, protective equipment and emergency procedures	Keep people away from any upwind of spill/leak. Keep out of low areas. Keep unnecessary personnel away. Wear appropriate personal protective equipment. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing. Ensure adequate ventilation.
